- The present status of land registry regarding council properties.
- Future cooperation with Wells Museum regarding storage of archives and concern that they should be available for public research. The museum should be recompensed appropriately.

The committee responded that the Land Registry issues were being dealt with in another committee and the matter of future cooperation with the museum was an agenda issue.

10/04A MATTERS ARISING AND REPORT OF ARCHIVIST.

Cllr Price reported the Heritage Week handbook had been received; the dates are 9th – 12th September 2010.

After discussion it was agreed to look at opening the town hall to the public on Sat 11th September 2010, giving guided tours and having an exhibition of archives.

The report from the Archivist was noted.

Asset Register was being compiled with photographic records.

A discussion took place as to the appointment of an archivist assistant, it was agreed that the chairman should meet the proposed candidate.

The Archivist reported that he was to meet the museum next week regarding future storage facilities.

10/05A FUTURE PROVISION OF ARCHIVES

Cllr Kennedy reported that at a meeting of the trustees of the museum, it was discussed about having more community involvement and the fact that City Council were looking at future storage facilities for the Archives, a room was available in the museum.

Cllr Siggs replied that he thought this would be a better profile for the archives but there is no time scale or remuneration at this stage. It was discussed and felt that this would be a two year project.

The minutes and records of the council would still be kept in the Town Hall for the life of the council.
