Domestic Violence and Abuse in Wells and how to raise awareness

- What is domestic violence and abuse?
- How to recognise it?
- Where can people concerned get help and support?

Beginning of 2023, I would like to create a campaign to raise awareness and to help to prevent violence happening in the first place.

Over the last 6 months, I had contact and meetings with different organisations and the police about this issue, it is a rising issue, there are organisations available to help victims and to educate and support offender to deal with their emotions in a healthier way.

It is a matter of bringing the organisation and people together.

According to Somerset Intelligence there were 3 areas in Wells 10 years ago where more than 10% of children were affected by domestic violence, more than 5% in the other areas. Unfortunately, I was not able to get more recent figures but overall the numbers are rising according to Avon and Somerset police and domestic violence is a big issue. 38% of crime is domestic violence. Isolation and the cost of living crisis is putting more pressure on families. Also these are only the reported figures; the real figures might be much higher.

Domestic violence can have a devastating effect on mental, emotional and physical health of the children involved as

What can we do to support these very vulnerable children and their parents in our community? Everybody should be able to feel safe at home and our aim should be to help to prevent violence in the first place. Violence can start subtle and slowly, also, it is more than physical, it can be verbal abuse and coercive control.

There are already a range of charities available to help the victims and the offender.

It is important to make this information available to people in need and also to raise awareness about the different nature of domestic violence.

Violence can have lots of different faces, like verbal abuse, belittling, controlling behaviour.

I would like to raise awareness by starting a campaign with leaflets, posters, information stand at the market, speaker, at the beginning of next year and will ask for support for this campaign in the full council meeting in January.

i Recreation Ground Trust Management Group

The group met on the 8th of December with five members of the public who had responded to the Wells Voice article.

The group had a very constructive discussion about the barn and the recreation ground with many ideas coming forward. From that group we will elect one resident who overlooks the recreation ground and one user who visits the recreation ground.

All management group meetings are public meetings and any member of the public and all councillors are welcome to attend.

The group identified immediate works that would improve the overall environment of the recreation ground, and the outside spaces team have already started working on these.

The group will be meeting on the 5th of January and will start to plan for the future of the recreation ground and the barn.

ii. Wells & Mendip Musem Report

The museum is making great strides in its journey to NetZero. The roof has been insulated and LED lighting installed throughout the building. The upgrade of the Old Kitchen has been carried out by repurposing materials we have to hand. All of this work has been carried out by our experienced volunteers.

Two of our Trustees have attended a Carbon Literacy training course with South West Museum Development, the successful completion of which leads to government accreditation. This has involved both individual and group work sessions with members from other museums looking at ways to reduce both individual carbon footprints and that of the museum.

They have studied the part that museums can play in tackling the climate crisis and green recovery and will be using these skills to help plan how we make changes and reduce our museum carbon footprint.

PLAY EQUIPMENT WORKS BEING UNDERTAKEN BY MDC

Schedule of works, for information. Provided by Mr Gavin Fear, Contracts and Asset Maintenance Manager, Mendip District Council

We are currently undertaking some play equipment works across the districts in various locations which have been identified as in need of refurbishment, where there has been no upgrade or replacement of items in the last five years or more. As the various ward members where these upgrades are planned to take place we wanted to ensure you are aware of the upcoming works.

A mixture of different types of Multi Play Units, (MPU), have been recommended by the team working alongside the contractor with the size of the locations considered, and where a second or third item has been recommended these will be either a roundabout, swings or see saw, as indicated in the table below.

The project will be funded through the Council, with some supplementary funding from Section 106, where it is available to use.

At present this is only a notification which doesn't require a response and/or isn't looking for feedback, we are only advising of the position to allow yourselves to be able to answer any questions you may have from constituents.
