- Stalls backed by local community groups.
- Stalls with local food and drink

Electricity supply to be supplied by a business based in the Market Square with a back entrance onto the green.

There will be a service in the Cathedral on the 7th. Starting at 3pm and lasting approximately one hour. This event will be considered in our planning. A member of the cathedral staff is an active part of the team.

Agenda Item 17 - Councillors Surgery

Summary of Councillor Surgery held on Monday 13th February 2023 in the Meeting Room, Wells Town Hall.

Present: Cllr Deborah Orrett

2 residents came with issues.

- 1. Barbara M from 105 Burcott Road was concerned that works carried out on the gas mains in Jocelyn Drive by Wales and West Utilities were causing noise and mess and restricting the width of the pavement outside her bungalow.
 - On inspection, I noted that a large storage container had been placed there by the company and earth was dumped and stored until it was collected by a lorry. Barriers had been placed around the area to contain it to the road but these had been pushed over the pavement making the passage narrow and muddy which would be slippery in wet weather.

Issue was resolved by W&W foreman moving the barriers and using an industrial brush to clean the pavement. Boards will also be placed under the soil heap in future to limit damage to the road surface.

- 2. Dr Christopher Spencer Jones came to gauge Councillor and personal opinion as to our vision for use of the Bishops Barn, as his role on Sarah Powell's Recreation Ground committee is to write a Consultation Document.
 - We discussed numerous options and locations for hire generally in Wells. Wider discussions ensued and he has experience with a Public Interest Entity. He would like to see more Community led projects.

Issue was resolved by putting him in touch with Mr Chris Charles who has approached me re: Community Land Trusts where land can be purchased and developed for community projects rather than massive commercial developments.
