  - MDC Planning are offering training for clerks/parish councillors/chairmen on 30<sup>th</sup> January and 11<sup>th</sup> February, 6-8pm.
  - Neighbourhood Plan The need to consider designation of Local Green Spaces was discussed.
  - Mast installation at Wells Cathedral: This matter was discussed and concluded that MDC decision was no need for planning application to install this mast. Apparently, no 4/5G signal involved, only a router, therefore no health implications. At the request of Cllr Rust, the Chairman undertook to report back on the matter to Andrew Haymes.
