- 1. The chairman handed out a 'House Extension Design Guide'
- 2. The 'Local Plan Part 2 Consultation' was discussed. It was agreed to a) accept Major Modification 52 to delete the Local Green Spaces listed in the Local Plan with a view to these and/or similar spaces being included in the Wells Neighbourhood Plan and b) object to MMs 53, 54 and 56 to substitute "A minimum of" for "Up to" in respect of allocated housing sites at West of Keward, Wells Rugby Club and Tincknells on the ground that any additional burden on the local infrastructure would be too great.
- 3. Cllr T Munt raised the issue of individual self builds being preferential to large number of builds. Also there is a need to save smaller houses and restrict number of house extensions making these houses unaffordable. It was suggested this should form part of the Neighbourhood Plan.
- 10th March, 6 8pm Wessex Community Assets are holding a meeting on Community Led Housing. Cllr S Briton is to attend and would like other Cllrs to also come along.

5. It was felt a public meeting should be held at Wells Town Hall where MP James Heappey should be invited to discuss the level of housing proposed for Wells & the extent of which these houses have energy saving measures incorporated. Proposed dates were Thurs 9th or 16th April. Chairman to discuss with Town Clerk.
