17/54CT MINUTES OF THE PREVIOUS MEETING

17/55CT MEETING OPEN TO THE PUBLIC

Ms Haworth CEO introduced herself and spoke about the City of Wells Almshouses. Members were asked to note that whilst the site is a beautiful and historic place to visit, it is peoples' private residential homes.

17/56CT WELLS MUSEUM VISITOR INFORMATION SERVICE Items from Mr Webb:

i. Mendip Tourism Ltd, draft <u>Destination Management Strategy for Mendip</u> The document was begun as part of the City of Culture bid process, it is a working draft. MDC (Cllr Killen) and Visit Somerset (John Turner) have been involved, they asked for the five towns to be informed; feedback is invited.

The Mayor suggested that a developed version would need to go through the committee process and to full Council at Wells City Council, also to Mendip District Council for adoption.

City of Culture 2021 DCMS feedback

The City of Culture Bid Panel gave a detailed response with very positive feedback to the Wells team. They were impressed with the ambition of the small cities. The bids from the smaller cities did not fit the criteria and could not compete with major post-industrial cities in the context of this competition. The Ministry will be holding a meeting with the smaller-city teams to consider the issues they all raised.

17/57CT PARKING AND SIGNAGE

Chamber of Commerce progress report.

Michael Johns has worked with SCC Highways to produce a report identifying signs to car parks at all entry points into the city. A schedule has been drawn up to introduce signage to long- or short-stay car parking; this is being progressed by SCC Highways with the City Council Planning Committee. It is hoped that the County Councillor will be able to assist in identifying funding for the project. Efforts have also been made by the Mayor, and others, to have a dialogue with MDC about car parks, particularly to identify figures showing the usage rates. Questions were asked about the recent use of Palace Fields for car parking. Very little was known about this situation; it appears to be a private matter between the owners and MDC.

17/58CT REPORTS

Visit by Coach project

The aim at present is to improve the arrival experience at the bus station both for passengers and for coach drivers.

The 'meet and greet' scheme has started, run by volunteers; vouchers etc. are handed out.

The Town Clerk has met with the bus company and with MDC; various projects are in progress to bring enhancements to the ticket office and waiting areas. There was once again a discussion about the coach point in Sadler Street, with varied opinions expressed. The Chairman asked that everyone send their suggestions in bullet points to the Town Clerk. These would be collated and brought to the next meeting, so that a consensus of options can be sent to SCC Highways.
