16/91C REPORTS FROM COUNCIL REPRESENTATIVES ON OUTSIDE BODIES & FROM DISTRICT & COUNTY COUNCILLORS

i. Wells Recreation Ground Trust

Cllr North reported the next meeting of the WRGT Committee will take place at Wells Town Hall on Tuesday 19th July.

It is anticipated that the new play area will be completed in early September.

ii. Wells Sports Council

Cllr Price presented the document stating the combined sports clubs application to MDC for a long-term lease.

iii. <u>Cllr MacKenzie</u> drew members' attention to the MDC presentation on Delivering Affordable Housing Solutions, to take place at Wells Town Hall on Thursday 21st July.

iv. Somerset County Council

Cllr Osman spoke about the progress of the devolution bid. He spoke about the improving quality of work in Somerset children's services.

Cllr Kennedy congratulated the county council on the way the sudden loss of a local bus service provider had been dealt with.

v. Mendip District Council

Cllr Siggs spoke about the recent access difficulties for the Glastonbury Festival, all parties had worked together. He spoke of the great benefits the festival brings to the whole county.

16/92C ANY OTHER URGENT MATTERS OF REPORT

Flag-flying

Cllr Swain referred to recent conversations and uncertainty around the suggestion to fly the rainbow pride flag at the Town Hall. He suggested the Council should clarify its flag-flying policy.

(Cllr Osman left the meeting).

The Mayor took comments from members expressing various points of view on the matter.

There are government guidelines and complex legislation on flag-flying.

The council's policy on flying the city flag is recorded in the Civic Review; council precedent and procedure on other flags could be reviewed and recorded.

(Cllrs Siggs, Kennedy and Robbins left the meeting)

The Deputy Mayor spoke on the interaction of local councils and global tragedies. He felt that the Mayor had led in paying respects in an entirely appropriate way, at the start of this evening's meeting.

In conclusion the Mayor suggested that Cllr Swain consult with members and with the Town Clerk and produce a draft flag-flying policy for council to consider.
