Variation of conditions 12,14 and 15 of permission 2011/0624 to amend operational hours such that: the external lighting shall not be illuminated other that between 05:30 and 22:30 hours on any day; the petrol filling station and shop hereby approved shall not open for business other than between the hours of 06:00 and 22:00 on any day; and the car wash hereby approved shall not open got business other than between the hours of 07:30 and 21:00 on any one day. REASONS:

- i. Access onto Glastonbury Road has not been sufficiently addressed; the committee considers that a single access route is insufficient.
- ii. The committee is concerned about safety on this busy road. The proposal has failed to take into consideration the amount of traffic already using the Glastonbury road and the additional traffic likely to be generated in future by this proposal together with other nearby development proposals.
- iii. There are service providers on the opposite side of Glastonbury Road, these generate turning traffic. They also generate pedestrians; the committee is concerned that there is no provision in the proposal for the safety of pedestrians crossing Glastonbury Road.
