Report from Local Community Network Meeting 10/10/24 (Agenda item 12(i) above)

The main focus of the meeting was effects of flooding in the parishes- actual in recent years and potential to come, with a presentation from David Mitchell and Bel Dearing from Somerset Rivers Authority.

What we learned was that the Somerset Rivers Authority is a partnership. SRA partners are:

- Somerset Council
- the Axe Brue and Parrett Internal Drainage Boards
- Environment Agency
- Natural England
- Wessex Regional Flood & Coastal Committee
- Wessex Water

And

There is no single answer to Somerset's many flooding problems. Different approaches are needed in different places, in varying combinations. The SRA as a partnership gets people working together more powerfully on suitable projects.

And

Somerset Rivers Authority is not involved in emergency responses to flooding or in flood recovery efforts. This means, for example, that the SRA does not supply sandbags, or set up pumps, or clear debris.

And

It has powers and funding but not Duties!

Each table was given a map showing watercourses/rivers in Mendip and we had to identify flood risk areas and our knowledge of why these are at risk- the information will be collated and sent out later along with an action plan for further working parties. It was suggested that we need to work in a greater context with other bordering LCNs to understand problems for water flow do no stop at the border!

Tom Shopland, FWAG, offered to visit areas with flood risk e.g. Tor Hill Lane and look at the possible causes upstream- he will do this following the Act to Adapt Plan is set up in Wells.

Fodo Higginson, SALC Community Health and Wellbeing Officer, informed the LCN meeting that SALC has sent out a video and she will follow up with another letter to inform Parish/Town Councils that there are funding opportunities for community projects and available to Councils:

£1500 Seed Grants for initial project ideas £2500 Small Grants for smaller or individual council projects £35000 Large Grants for collaborative projects involving multiple councils

The LCN agreed that it might be positive to all work together to achieve the last pot of funding on a shared project such as youth work.
