## Introduction and Background

There are many actions being supported either directly or indirectly by the City Council, associated with highways of traffic within the City. As this committee has newly included this topic as a standing item, it was considered appropriate to provide an update of all known and current issues or actions, to allow the committee one update, following which, actions can be provided at each meeting to update specifics that have taken place. The table below offers a view of each project.

It should be noted that this report and the below table takes into consideration actions within the Memorandum of Understanding between Wells City Council and Accessible Wells, as well as Somerset Council and Wells City Council.

There are 16 identified projects within the Accessible Wells and Wells City Council MOU and these are highlighted in red within the table where applicable.

Market Place Traffic Regulation Order (TRO) (Identified MOU Project)	Implement permanent order to replace the back to back temporary orders that have been in place for some years, seeing improved signage and understanding of use of the space and restrictions.	Wells City Council	Somerset Council	The order draft was discussed with Somerset Council on 6 <sup>th</sup> August 2025, awaiting final draft. There will then need to be consultation completed with surrounding businesses (although TC of WCC has already engaged with all local businesses and no negative feedback received) before the order is finalised and sealed. At present, a temporary order is in place. There will be a need to amend signage at the front of the market place to ensure all are aware that the space will be a Pedestrian Zone (note the different wording from the temporary order).
20MPH Speed Limit Adjustment	Increase the 20MPH zone across the city to encompass all school locations and all areas considered part of the immediate city centre.	Somerset Council	Wells City Council Accessible Wells	Proposal for the current 20 mph zone to be extended outwards and additional signage to be placed on the road surface and on repeater signs to remind motorists and create a compliant zone. This would see all schools within the City covered with a restriction, and resolving concerns in multiple locations.  Cost implications need to be considered by WCC as part of 2026-27 budget setting, as extending the zone further than phase one suggestions would need to be absorbed by WCC.
Sadler Street Bay Amendments (Identified MOU Project)	Bus stop movement and loading bay adjustments	Somerset Council	Wells City Council	There have been some concerns raised regarding the bus stop at the end of Sadler Street, adjoining the Market Place causing obstruction, and suggestion to utilise the coach pull in at the start of Sadler Street as a replacement stop, thus allowing free flowing of traffic. In addition, the adjacent loading bay is often not used for loading, but short stay parking, and isn't actively monitored. It is

				proposed that the loading bay hours be extended to 8pm (currently 6pm)

Whilst the police are keen to support, they can not do so without confirmation of the order that is relevant to the space.  Somerset Council can not locate the original order and as such are having to reapply through the normal process, including consultation, for a new provision. Once this is in place, the action days can be arranged.

Checks being completed to devices to ensure they are correctly calibrated and able to be deployed.  Town Clerk will engage with Accessible Wells, Somerset and Avon and Somerset Police to determine and apply necessary governance and protocol for deployment as well as "hot spots". White Line review	Review of all white lining within the city to ensure markings remain fit for purpose and can be enforced against.	Somerset Council	Wells City Council	Following advise from Somerset officers, that contractors had not been able to complete works before the end of contract, and thus, any information would be lost on transfer, Wells City Council OS Team supported a standalone audit of white lining within the city, to map, photograph and accurately document where there were lines which were considered below tolerance. This information was passed to Somerset Council in June 2025and we awaiting confirmation of the work schedule for completion. It was felt that supporting this action would aid in the overall look and feel of the city, and its cleanliness.

Dropped Kerbs (Identified MOU Project)	Consider and apply remedial action to locations where dropped kerbs are unsuitable or eroded in some manner. Tor Street/Moat crossing identified by Accessible Wells as significant gap in network of accessible pathways around the City. Traffic Lights (Identified MOU Project)	The audible signals to be reinstated on all traffic lights between 08.00 and 21.00 hours in order to comply with the needs of blind residents and visitors of the city.
