1 Respective responsibilities of the auditor and the authority

Our responsibility as auditors to complete a **limited assurance review** is set out by the National Audit Office (NAO). A limited assurance review is **not a full statutory audit**, it does not constitute an audit carried out in accordance with International Standards on Auditing (UK & Ireland) and hence it **does not** provide the same level of assurance that such an audit would. The UK Government has determined that a lower level of assurance than that provided by a full statutory audit is appropriate for those local public bodies with the lowest levels of spending.

The smaller authority has submitted its AGAR and supporting documentation prior to 30 September 2025; however, we have not been able to complete our review work in time to enable the smaller authority to publish the required documentation in line with statutory requirements. Once we have completed our review a final report will be provided with the certificate of completion detailing any qualifications and ‘other’ matters.

External auditor's limited assurance opinion 2024/25

On 28 September 2025, we issued a report detailing the results of our limited assurance review of Sections 1 and 2 of this authority's Annual Governance & Accountability Return for the year ended 31 March 2025. We explained that we were unable to certify completion of the review at that time. We are now in a position to certify completion of the review.

The external auditor report given in Section 3 of the Annual Governance & Accountability Return requires amendments as follows:

Except for the matters reported below, on the basis of our review of Sections 1 and 2 of the Annual Governance and Accountability Return (AGAR), in our opinion the information in Sections 1 and 2 of the AGAR is in accordance with Proper Practices and no other matters have come to our attention giving cause for concern that relevant legislation and regulatory requirements have not been met.

- 1) The smaller authority has disclosed that it made proper provision during the year 2024/25 for the exercise of public rights, by answering 'Yes' to Section 1, Assertion 4. However, as was reported last year, we are aware that it failed to do this and therefore should have answered 'No' to this Assertion. It has also disclosed that it took appropriate action on all matters raised in reports from internal and external audit, by answering 'Yes' to Section 1, Assertion 7, which, on the basis of the above, is not correct.
- 2) Section 1, Assertion 1 has been incorrectly completed. Information received from the internal auditor highlights that the smaller authority did not have an investment strategy or policy in place during the year under review. As a result, this assertion should have been answered 'No'.

- 3) Section 1, Assertion 5 has been incorrectly completed. Information received from the smaller authority highlights that risk management arrangements were not reviewed and approved by the authority as a whole during the year. As a result, this assertion should have been answered 'No'.
- 4) The AGAR was not accurately completed before submission for review:
 - We note that while the AGAR has been amended to remove trust fund transactions and balances from the current year figures, the prior year figures have not been restated accordingly. As a result, the opening balance in Box 1 of the current year does not equal the closing balance in Box 7 of the prior year. We also note that at the year end the trust funds were being held in a bank account belonging to the smaller authority but that this has been rectified during 2025/26.

Other matters not affecting our opinion which we draw to the attention of the authority:

- 1) The smaller authority has confirmed that it has not complied with the governance Assertion in Section 1, Box 9, and it has provided the appointed auditor with an adequate explanation for non-compliance and details of the actions necessary to address weaknesses identified. This is consistent with the responses given in Section 2 Box 11a, 11b and consistent with the internal auditor's response to ICO O.
- 2) The AGAR was not accurately completed before submission for review. The AGAR has been amended.
- 3) The smaller authority should ensure that it has regard to the level of reserves held when considering future precept requests. We note that once the trust balances were removed from the figures, the year end reserves were very low, especially in light of the level of debtors at the year end. We also note that the smaller authority has a plan in place to rectify this situation and has been working on this during 2025/26.
